Each property boasts attractive character 2 bedroomed accommodation although the main bedrooms are of sufficient generous proportions to probably easily divide to create third bedrooms if so desired; sycamore cottage is also sensitively designed to accommodate disabled users with assistance, as well as able bodied guests (*last 3 years audited accounts will be made available for perusal by discerning interested parties only*).

The properties are situated in an idyllic picturesque small hamlet setting approx 1 mile along a back lane out of Burton-In-Lonsdale village conveniently located on the Yorkshire, Lancashire and Cumbria borders.

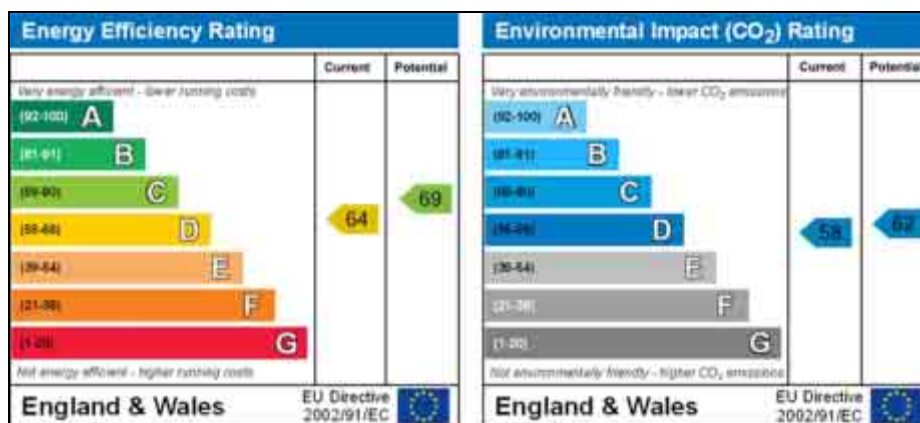

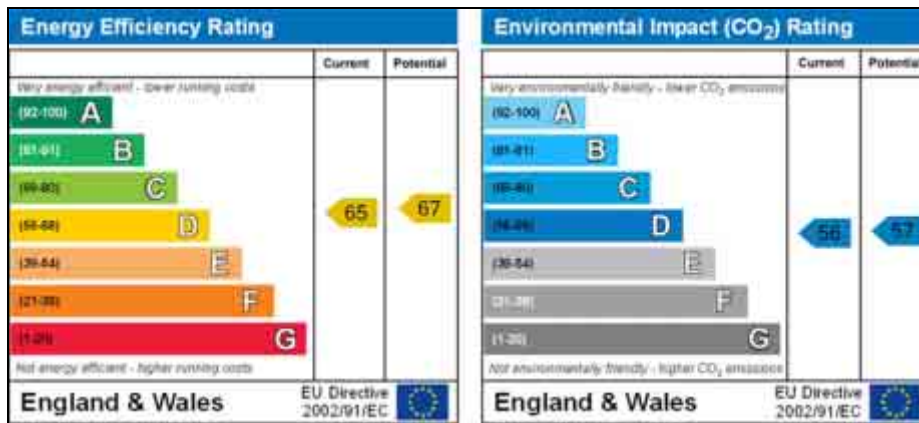
